

ORDINANCE NO. 25-01
CITY OF GOOD THUNDER
AN ORDINANCE AMENDING SECTION 34.01 (FEE SCHEDULE) OF THE
CITY THUNDER CITY CODE,

WHEREAS the City Council of Good Thunder believes that it is in the best interests of the residents of the City of Good thunder to amend its Ordinances to repeal the current language of Good Thunder City Code Section 34.01 and to amend it as follows:

BE IT RESOLVED that the City Council of the City of Good Thunder does hereby ordain as follows:

That the language Good Thunder City Ordinance Section 34.01 is hereby repealed and the following the following language hereby enacted, and shall replace that language and the Ordinance shall read as follows:

34.01 Salary and Fee Schedules.

The City shall maintain a fee schedule that is available to the public at City Hall. The City Council shall set compensation and the rate of fees annually by resolution at its first meeting in January. Fees may be adjusted by council resolution.

(A) *Compensation of Appointed Officials.* The compensation of the City Clerk, Police Department, Street Department and any other City Staff position shall be as budgeted.

(B) *Compensation of Elections Judges.* The compensation for election judges will be set annually on the City Fee Schedule.

(C) *Compensation of the Fire Department.* The compensation for the Fire Chief, Assistant Fire Chief and Volunteer Firefighters shall be set annually at the first council meeting of the year. The Fire Department shall provide any proposed changes to the compensation to the City Council by July 1, of the year prior to enactment so that it can be included in the City Budget.

(D) *Compensation of the Mayor and City Council.* The

compensation of the Mayor and City Council shall continue as previously set and may be modified as follows: if the rate or compensation is going to be increased any increase may take effect only after the next council election; any decrease in pay may take effect immediately.

(E) *Rates and Charges for municipal utilities.* The City shall set rates for the installation and provision of city utilities including but not limited to sewer connection fees, contingency charges, permit and inspection fees, and sewer and water rates. The City may also impose a late fee, returned check fee, and interest upon any delinquent account. The rates and fees shall be established a resolution and modified by resolution. Any interest fee charged to an account may not exceed 18% per annum.

(F) *Business License Fees.* The City shall set the amount of the business license fees required under the code by resolution and set annually on the City Fee Schedule,

(G) *Liquor and beer License Fees.* Consumption and Display permit fees, intoxicating liquor license fees, investigation fees, non-intoxicating malt liquor fees, wine licenses fees shall be set by resolution of the City Council and placed on the City Fee Schedule.

(H) *Cannabis Business Registration.* Registration fees for any business that has obtained a license for the Minnesota Office of Cannabis shall pay a fee as set by the City Council by resolution and placed on the City Fee Schedule.

(I) *Maintenance Fees.* Shall be set by the City Council by resolution and placed on the City's Fee Schedule.

(J) *Rental fees for City Hall.* A damage and rental fee may be required for the use of the City Hall. The City Council by resolutions shall set the amount of the deposit and the rental fee by resolution and placed on the City Fee Schedule.

(K) *Rental Fees for Concession Stand.* A damage deposit and rental fee may be required for the rental of any city owned concession stand and the amount of the damage deposit and rental fees shall be set by resolution of the City Council and placed on the City Fee Schedule.

(L) *Zoning and subdivisions fees.* The City Council shall set a conditional use permit fee, plat fee, variance fee, zoning

amendment fee and zoning permit fee by resolution and the fees shall be placed on City's Fee Schedules. In addition to the required fees all zoning and subdivision applicants are responsible for the expenses of the City involving any meeting and/or publication incurred by the City as a result of the request.

(M) *Miscellaneous fees.* The City Council may set other fees. Any such fee will be created by resolution and placed on the City Fee Schedule.

Effective Date. This ordinance shall take effect and be in force from and after its passage and publication in accordance with law.
